**Certificate of Insurance**

**Missouri State Statutes 287.061** states "a contractor in the construction industry shall be required to have a certificate of insurance for worker's compensation coverage or an affidavit,..., signed by the applicant attesting that the contractor is exempt".

**City of North Kansas City Code** requires a **Certificate of Insurance** showing proof of worker's compensation insurance coverage and in certain cases liability insurance coverage, with the **City of North Kansas City, Missouri named as certificate holder**. However, if your company is to do business with the City of North Kansas City Missouri directly, the City will need to be listed as additional insured with regards to the liability insurance coverage. This certificate **must** be on file prior to issuance of the business license. Certificates can be faxed to (816) 421-5046 or mailed to: City of North Kansas City, Attn: Business Licensing, 2010 Howell St., North Kansas City, MO, 64116.

If the contractor is exempt from worker's compensation, an Affidavit of Exemption for Workers' Compensation Insurance form is required.
